### ISNetworld Conducts Safety Workshops for EnCana CFD in Western Canada

DALLAS (July 30, 2009) – ISNetworld has been asked by its client, EnCana Canadian Foothills Division (CFD), to assist with safety workshops for small contractors in western Canada during the EnCana CFD Contractor Assistance Program.

The ISNetworld portion of the session is designed to assist smaller EnCana CFD contractors, those with less than 20 employees, with safety program compliance. The sessions are being held in 11 cities throughout western Canada from June 3 through August 13, 2009. Through the Contractor Assistance Program and EnCana-hosted Users Group Meetings, EnCana and ISNetworld have met with more than 2,500 contractors year-to-date.

"We recognized internally that many of our contractors have in the past created safety programs to meet objectives other than strict legislation compliance," stated Andrew Box, ISN Implementation Lead with EnCana CFD. "Other contractors have been brought into EnCana and mistakenly thought that our corporate safety program covered their individual activities, which is not the case." He added, "So, we developed a three-day program to assist contractors in identifying gaps between their present program and what legislation actually requires. This allows them the opportunity to produce revised programs that will meet the standards expected in the ISNetworld RAVS review."

According to Jeremy Ries, ISNetworld EnCana account manager, the safety workshops are the perfect opportunity for contractors to learn the steps for setting up safety programs and to meet one-on-one with an ISNetworld representative to answer health and safety questions for their respective provinces. Contractors also learn what is necessary to meet minimum OH&S requirements and how to remain a preferred vendor for EnCana CFD.

"Participating in this program allows ISNetworld to reach out and discuss health and safety initiatives that help create a culture of safety that meets EnCana CFD's requirements and ensures their employees go home safely to their families," said Adrienne Turner, ISNetworld director.
